



## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.rep18.com](http://www.rep18.com) and Rep18 and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Rep18 include [www.rep18.com](http://www.rep18.com). The Rep18 website is an ecommerce site. ### **Collection of your Personal Information**

Rep18 may collect personally identifiable information, such as your name. If you purchase Rep18's products and services, we collect billing and credit card information. Information about your computer hardware and software may be automatically collected by Rep18.
